\* All mares that provide a 30-day clean uterine culture will receive a \$30 discount on that shipment of semen. Only one discount per cycle. Additional discounts may be given for follow up cycles with another 30-day clean culture. Culture results must be sent and received by Tiany Schuster before discount will be given. First shipment of semen shipped at no charge only to non discounted paid in full 2008 contracts.

## ALL SEMEN ORDERS MUST BE REQUESTED NO LATER THAN 12 NOON CENTRAL TIME.

All correct completed travel documents must accompany mare. If a mare should leave the boarding stud after service or scanning of foal and thereafter wish to return, it may be required to provide additional proper health papers. EVA Seropositive mares must have a stable or declining titer before Tiany Schuster will accept mare on farm. This MUST be CERTIFIED before shipment of mare to farm.

In signing this document, the above owner/agent releases Tiany Schuster of any and all liabilities. The owner/agent authorizes Tiany Schuster to act on their behalf in case of an emergency and not hold Tiany Schuster liable for any decisions made or incidents that may occur. Any legal fees that Tiany Schuster may incur due to any and all litigations that may arise from the inherent risk of this contract shall be the mare owner's responsibility. **ALL FEES MUST BE PAID BEFORE ANY HORSES ARE RELEASED OR SEMEN IS TO BE SHIPPED.** Any unpaid fees and expenses will bear interest of eighteen percent (18%) per annum until paid. The unpaid balance of each amount is due and payable

within 10 days of receipt of service that was provided. Any past due account which shall not be paid within thirty (30) days of service shall be subject to collection, including charges, expenses, attorneys fees and related cost which shall be incurred in the collection of balance. Mare shall be in healthy and sound breeding condition upon arrival to farm and MUST have a current 6-month coggins and a 30 health certificate. Mare owner agrees to pay for all necessary veterinary expenses incurred in the care and breeding of the mare and care of foal. Mare Owner agrees to use his or her reasonable best efforts to settle the Mare. If, however, the mare does not settle, Mare Owner will hold Tiany Schuster harmless from any loss or damage. Mare will be released when all fees and expenses, including veterinary charges, are paid. "Live Foal Guarantee" guarantee is for 30 days after foaling date. If foal dies, a veterinary certificate of death is required and breeding must be used in the 2009 breeding season. Mares on farm have first service over shipped semen. Shipped semen will only be available after mares at farm are bred for that day. Shipped semen is available ONLY for shipment on Monday-Wednesday-Friday. Each mare will only be allowed three shipments per season. If mare is still declared not in foal, mare must be sent to breeding farm for future service(s). THERE IS NO GUARANTEE OF QUALITY OF SHIPPED SEMEN. If there is any problem within the first 24 hours of shipment, notification must be given IMMEDIATELY. Any irregularities in semen after 24 hours are the responsibility of the receiver. Considerations will only be given for semen less than acceptable, prior to 24 hours, only after compared to other shipments and/or semen sample held back for analysis. The horses named in this contract are non transferable unless, the horses named were to die or become unfit for service. If the named stallion were to die or become unfit for service frozen semen would then be available at mare owners expense. If frozen semen were not available, stud fee, less booking and all other expenses, would only then be refunded. If named mare were to die or become unfit for service, a substitute mare with the same owner will then be allowed with the approval of Tiany Schuster. Tiany Schuster must immediately be notified and have a veterinarian certificate of proof. THERE WILL BE NO REFUNDS OF ANY KIND. All monies paid are NON REFUNDABLE, regardless of payment type (including credit cards), services received or not received, nor quality of goods. Mare owner agrees that all credit card transactions are final at time of processing, regardless of outcomes or decisions made at a later date. All out of country payments must be made in CERTIFIED FUNDS. All credit card transactions bear a 5% processing fee. No credit cards will be accepted unless residing in the United States. You cannot sell nor transfer breeding. All fees are non-refundable and booking fee reserves one breeding. Mississippi law governs this Agreement and Contract, of the terms provisions of which are performed in Forrest County, Mississippi. The parties agree that any legal action brought under this Agreement and Contract or pertaining to the subject matter of this Agreement/Contract can only be brought in Forrest County, Mississippi. Contract must be completed or it will not be accepted. I have read, understand, and agree to the terms and conditions. **Please sign & make a copy for your records.**
